Melbourne: An Australian judge fined X Corp 6,50,000 Australian dollars (US \$4,65,000) on Thursday for failing to provide information to an online safety watchdog in 2023 about how it tackled child sexual exploitation content. Federal Court Justice Michael

Wheelerhan also ordered the Texas-based social media giant to pay AUD 1,00,000 (US \$71,000) of eSafety Commissioner Julie Inman Grant's court costs within 45 days.
